## What are cookies?

Cookies are small text files stored on your device (computer, smartphone, tablet) when you visit a website. They are widely used to make websites work efficiently, as well as to provide information to site owners. Cookies can be:

1. **First-party cookies:** set by the website you are visiting
2. **Third-party cookies:** set by domains other than the website you are visiting

## Types of cookies we use

We use different types of cookies for different purposes. Below is a breakdown of the categories:



Cookie Type	Purpose	Examples	Retention
Functional	Improve general performance and functionality of the website.	To allow easy login or remember a user's region.	Depending on the purpose of the types of cookies, it can vary from session only to up to 12 months (depending on browser settings).
Performance	Track website visitors and their user behaviour.	To improve the way the website works and in turn, used to improve user experience.	Depending on the purpose of the types of cookies, it can vary from session only to 1 year and 1 month.

## Lawful basis for collecting and processing personal data

We rely on the following legal bases under the GDPR:

1. Consent – for all non-essential cookies (i.e. targeting, advertising, analytics, etc.) we rely on your consent. Consent is collected via the cookie banner
2. Legitimate interest – for strictly necessary cookies needed to deliver website functionality

You may withdraw or modify your consent at any time by adjusting your preferences through our Cookies Script cookies consent manager.

Cookie key	Domain	Cookie type	Expiration	Description
_ga	circle-academy.com	First-party	1 year 1 month	This cookie name is associated with Google Universal Analytics - which is a significant update to Google's more commonly used analytics service. This cookie is used to distinguish unique users by assigning a randomly generated number as a client identifier. It is included in each page request in a site and used to calculate visitor, session and campaign data for the sites analytics reports. By default it is set to expire after 2 years,



				although this is customisable by website owners.
_ga_FV80Z01QGM	circle-academy.com	First-party	1 year 1 month	This cookie is used by Google Analytics to persist session state.

VISITOR_INFO1_LIVE	.youtube.com	Third-party	6 months	This cookie is set by Youtube to keep track of user preferences for Youtube videos embedded in sites;it can also determine whether the website visitor is using the new or old version of the Youtube interface.
YSC	.youtube.com	Third-party	Session	This cookie is set by YouTube to track views of embedded videos.
